- 2. Only registered firms can submit their bids having NTN and STRN numbers.
- 3. Bidders can visit Logistic/Cement/Stim Base, Tando Alam, to physically check Cement Slurry Mixer.
- 4. The Bid will be opened on the date as mentioned in the tender notice, the bidder may show his presence at time of bid opening.
- 5. Surety bond (in form of Pay Order) of Rs. 100,000/- (One Hundred Thousands Rupees) in favor of Operation Manager Logistic Field Tando Alam at time of bid submission by all participants.
- 6. Bidder must submit drawings along with bid.
- 7. Bidder will be responsible to assure all technical aspects.
- 8. Dismantling of old Tank, piping and Installation of new tanks with new piping, flanges, valves where ever required will be covered on same bid.
- 9. Bidder will be responsible for fabrication of Tanks foundation and installation of low pressure manifold with no cost to OGDCL.
- 10. OGDCL will provide hydraulic motors and agitator but proper fixing will be the responsibility of bidder with no cost to OGDCL.
- 11. OGDCL will arrange mobilization and demobilization of CSM (Inventory # 1402) at bidder's workshop. However, Bidder will arrange Crane for loading/offloading at their facility.
- 12. Bidder will return existing tank of CSM to OGDCL.
- 13. Bidder will be responsible to complete assignment within 12 weeks.
- 14. Bidder will provide one-year warranty, in case of any failure during warranty period bidder will fix the issue with no cost to OGDCL.

- 15. The delivery shall be made after inspection of equipment by committee of Logistic/Cement/Stim Base, Tando Alam or 3rd party inspection.
- 16. Payment will be made through cross check.
- 17. Taxes will be deducted as per company policy.
