3. The quotes will be opened on the date as mentioned in the tender notice; the supplier can mobilize his representative to site.

4. Technical Bids will be opened for evaluation, results will be uploaded on website. Financial Bids of technically responsive bidders will be opened afterwards as per PPRA rules.

5. Quoted prices must be firm in Pak rupees on FOR basis (inclusive of GST, other taxes, and duties).

6. The variation in Quantity will not change the unit cost of material. The Purchaser shall have the right, at his exclusive discretion, to increase/decrease the quantity of any or all item(s) without any change in unit prices or other terms and conditions, at the time of order placement.

7. Upon receipt of material at site, pressure testing will be done, in case of test failure, material will be returned to supplier , at the cost will be borne by of supplier.

8. All fittings, Tubings, Valves, etc will be 10K psi, except where mentioned explicitly. SAWGLOK, Parker or equivalent, With material certificate and test certificates.

9. Original material test certificates will be provided with material. All fitting must comply relevant standard/ASME.

10. Bid bond (Bank Draft/Pay Order) of **Rs 2% of the quoted total amount/**in favor of Field Manager Nashpa Oil & Gas Field at the time of bid submission by all participants.

11. The successful bidder will be bounded to provide the material as per specifications mentioned in the TOR.

12. The successful bidder will be responsible to provide all the materials within 45 days after the issuance of P.O.

13. No advance payment will be made at the time of P.O.

14. The delivery and inspection of material will be carried out at Nashpa Oil Field. In case of rejection, all the transportation charges will be at Supplier's end.

15. The material delivery charges to Nashpa Field will be paid by the Supplier.

16. Income tax/w. holding tax deductions will be applicable as per company/govt. rules.

17. The payment will be made through cross Cheque after receiving the mentioned material at site.

18. The firm should have valid NTN and GST number and have active status on FBR website.

19. The Firm should have active Professional tax certificate of concerned Excise office where operating business.
