6. Spares will be accepted after final inspection and functional test at site, and payment will be made through Cross cheque thereof
7. The firm should have valid NTN and GST no's and have active status on FBR website.
8. The Firm should have active Professional tax certificate of concerned Excise office where operating business
9. Tax submission Certificate(Annex-C) will be provided along with Invoice
10. BOE, GD or SRO to be submitted along with invoice for Income tax/GST exemption if any.
11. Any change in the quantity of the parts, as mentioned in the SOR, at the time of placement of order shall have no effect on the unit price of an item.
