

**ANNEXURE "A"****TERMS AND CONDITIONS**

Sealed bids are invited under Competitive Bidding Procedure on Single Stage single Envelope Bidding Procedure. The bid shall contain both financial proposal and technical proposal. Bid should be valid for 45 days.

01. Bidders are required to comply all the term & conditions mentioned in Annex-A and tender notice.
02. 100% payment will be made through cross cheque only payable to suppliers company after completion of assignment and submission of invoices, annex "C" with required documents and completion of store and accounts procedures.
03. All admissible taxes will be deducted as per rules.
04. Transportation/Mobilization & de-mobilization of gas generator will be on the part of the supplier.
05. Unloading & loading of gas generator will be provided by OGDCL at site under suppliers supervision. OGDCL will not be responsible for any damage occurred during unloading / loading of gas generator.
06. Operation/servicing staff will be provided by the supplier.
07. OGDCL will provide accommodation for only 03 Nos of operation/servicing staff.
08. OGDCL will provide supply of fuel gas and water only at site for gas generator.
09. OGDCL will not be responsible for any damage/loss to generator at site during operation.
10. The supplied Generator shall be equipped with control panel having necessary protections.
11. Installation & Commissioning of supplied generator will be done by the supplier.
12. Servicing of the generator, routine maintenance, Top End, Mini & Major Overhauling trouble shooting will be done by the supplier.
13. Lubrication and supply of necessary consumables like lube Oil, lube Oil Filters, Air Filters & gas generator parts shall be supplied by the supplier
14. Stationary to maintain the Gen Set record shall be supplied by the supplier and complete logging shall be provided after completion of assignment.
15. Last maintenance record, Total Running Hours and Year of manufacturing of supplied generator shall be provided by the supplier in technical evaluation.
16. The supplied generators shall be capable (as a prime source ) to cater continuous residential camp loads 24 hours for electricity and air conditioners use as per generator rating.
17. The contract time will start when generator to be put on load by the site team.
18. Power Cables, minimum of 10 meter each length as per rating.

19. In case of complete failure of generator set, the supplier has to provide replacement within 12 hrs of gas generator having same capacity.

20. In case of malfunction / stoppage of gas generator at site, the deduction will be made in the following manner:

a	Continuous stoppage for more than 06 hrs.	Deduction of full day payment .
b	Continuous stoppage for more than 12 hrs.	to replace the generator set with deduction of full day payment.
c	Failure to replace/repair the gen set within 24 hrs.	the contract will be cancelled without any claim.

21. The supplier will have minimum of 05 years of past experience in the supply of same item.

22. The qualified bidder shall provide generator at OGDCL site within week time after service order being issued and commissioning time shall be three days.

23. The tender committee reserves the right to increase or decrease the number of days on same rates or may cancel the tender without assigning any reason thereof. The payment will be made according to actual days, the generator utilized after being verified invoices from I/C electrical/P.M Dakhni.

24. Inspection of generator shall be carried out by site committee prior to taking in operation and any kind of load test shall be the responsibility of supplier.
