

2. Only FBR registered bidders can submit their bids having NTN & STRN.
3. Surety bond, 05% of total bid value, will be submitted at the time of bid submission by all bidders in favor of **Operation Manager Logistics Field, OGDCL, Kot Sarang Talagang**.
4. The quotes will be opened on the date & time as mentioned in the tender notice. The bidder can send his representative to site.
5. Product should be of market repute.
6. Successful bidder will be responsible for provision of entire consignment as per specifications of web tender at **Cementation/ Stimulation Base /Logistics Field, Kot Sarang, Talagang** within 21 days after award of Supply order.
7. Material will be accepted after the physical inspection & evaluation by committee of OGDCL Cementation base at Logistics Field Kot Sarang.
8. Packing must be in Sealed Drums having 208 or 210 Liters per Drum.
9. Packing Drums must be properly sealed and water proof.
10. Each drum must be labeled properly showing Manufacturer details, Quantity, Specifications, Manufacturing/Expiry details, Handling precautions.
11. MSDS (Material Safety Data Sheet) must be provided.
12. On receipt of the consignment, if it is found short consignment, substandard after use, then the supplier shall have to lift the entire rejected consignment and replace the substandard material with the material conforming to the tender specifications at his own cost within Fifteen (15) days.
13. Performance Security, 10% of total bid value, to be retained from successful bidder until satisfactory field performance of the product.
14. The payment shall be made after satisfactory inspection report by committee of OGDCL Cementation base Kot Sarang Field.
15. The payment shall be made through cross cheque/online after deduction of all applicable taxes.
