Following Clarifications have been made in the subject tender.

1	Petrography data (thin sections, XRD, SEM etc..) required, there is any available? If not, what is the minimum number required for thin section?	Approximately 7-9 samples per well for thin section/ petrographic study –from cores in cored wells and cuttings in uncored wells.
2	Is it required to have XRD/XRF for all thin section samples? If no, what is the minimum number of samples from cores?	Approximate 4-5 sample per well to be studied
3	What is the minimum number of XRD/XRF from cutting required for the uncored intervals?	Approximate 4-5 samples per well to be studied
4	What is the minimum number of samples on which Biostratigraphy needs to be performed?	1-2 sample from each major Sand /reservoir unit in each well with consent of OGDCL professionals.
5	What is the minimum number required of thin section for CL (Cathodic luminance) and SEM?	Approximate 4-5 samples per well to be studied
6	Is fluid inclusion analysis is required to be performed?	Yes
