2. The OEM of Pipe and fitting must have 10 years of experience in manufacturing of Industrial pipes and fitting and also have API certification.
3. No advance payment will be made at the time of PO. Payment will be after delivery/inspection and submission of annexure ‘c’ with submitted status
4. Material Delivery Timeline should not be more than **08 weeks** from the date of Purchase Oder issuance.
5. Supplier shall submit quoted brand material Specification Data sheets along with technical bid.
6. Supplier will have to deliver the material at Loti Gas Field with Paid Bilty in original OEM packing. Packing of material should be for long distance transportation. Any damage during transportation will be borne by supplier.
7. Inspection of material will be carried out by the OGDCL rep. at Loti Gas Field.
8. Supplier will have to replace the Off-spec & Rejected material without any extra charges.
