8. Supplier to provide all necessary documents like Annex-C (Tax), professional tax certificate etc. with invoice.
9. The material will be delivered at Dakhni Plant, the delivery charges to Dakhni gas processing plant to be borne by the supplier / bidder.
10. Bidder should submit complete/clean acceptance of OGDCL TOR.
