The request for extension of closing date and time shall not be entertained and tender received after closing time or date shall be returned to Bidder unopened.
7. The Purchaser reserves the right to increase or decrease the quantities / Scope of Work and accept or reject any or all bids or cancel any or all items at anytime without assigning any reasons thereof.
8. The bid proposal should essentially include C.Vs of the professionals expected to be deployed for the said job.
9. The Service Order shall be interpreted in accordance with the law applicable in Pakistan.
10. Payment will be made on submission of your invoices along with inspection report carried out by the company as per provided TOR.
11. The price charged by the Service Company for required services shall not vary from the prices quoted by the Service Company.
12. The contract / service order will remain valid till completion of job / period specified in Terms of Reference (TOR) at Annexure "A". Any extension in validity of contract / service order will be subject to written mutual consent of both the parties.
13. On acceptance of the bid by the Purchaser the successful bidder shall be required to furnish Performance Bond / Bank Guarantee for an amount equivalent to 10 % of the Contract value for the required Services in US Dollars or in currency of Bidder or equivalent in Pakistan
14. The bidder shall bear all costs associated with the preparation and submission of his bid and OGDCL will in no case be responsible or liable for those costs, regardless of the outcome of the bidding process.
15. Contract price will be subject to adjustment as a result of addition/reduction in scope of work. However, unit price quoted for such work shall be used as base price for computation of final invoice. Contractor should take approval for such changes in writing from OGDCL. Rates and quantum of any additional job, not covered in the scope of work shall be subject to approval of OGDCL.
16. The bid must be prepared and submitted in the English language. Supporting documents and printed literature furnished by the bidder with the bid may be in another language as long as they are accompanied by an English translation of the pertinent passages. For the purpose of interpretation of the Bid, the English language shall prevail.
17. Any Bid received after deadline for submission of Bids prescribed by OGDCL will be rejected and returned unopened to the bidder.
18. The bid must be strictly in accordance with our Terms of Reference and quoted price must be firm. No late bid/no extension shall be entertained. Please ensure to submit your proposal as stipulated above.
