8. Custom clearance in supplier's scope.
9. The material will be delivered at Dakhni Plant Jand,Dist.Attock, the delivery charges to Dakhni gas processing plant to be borne by the supplier / bidder.
10. The tender committee reserves the right to increase or decrease the quantities or may cancel any or all items shown in the SOR without assigning any reason thereof.
