- 2 The supplier should have a minimum of 5 Years of past experience for supply of the same nature of items.
- 3 No any advance payment will be made at the time of PO. Payment will be made after complete delivery, inspection and acceptance of items on site through cross cheque. Also submission of annexure-C in submitted status.
- 4 Material Delivery Timeline should not be more than **06 weeks** from the date of Purchase Oder issuance.
- 5 Recmended brands are as follow Hilti, Black And Decker, Mitabo, Black & Decker, Makute, Sencan, Boky, Stanley, Coofix, Hyundai, Crown, Deli, Ingco, Daewoo, ES Tools, King, Bosch, Dewalt, And Makita
- 6 The material will be delivered at Jhal Magsi gas Field-OGDCL in packing. The delivery charges to Jhal Magsi gas Field to be borne by the supplier / bidder.
- 7 Detail inspection of material will be carried out on-site after delivery. If discrepancies are found, the same will be rejected without any claim/charges.
- 8 Supplier will have to replace the Off-spec and rejected material without any extra charges.
- 9 The tender committee reserves the right to increase or decrease the quantities or may cancel any or all items shown in the SOR without assigning any reason thereof.
- 10 Income/withholding tax deductions will be applicable as per Company/Govt. rules.
- 11 Bidders to submit their company profiles, experience of similar supplies in Pakistan along with technicl bids.
- 12 Bids evaluation criteria will be full consignment wise on the basis of technical specs and material delivery period. The items are required in one shipment, partial delivery will not be allowed.

- 2 FINANCIAL BIDS OF ONLY TECHNICALLY RESPONSIVE BIDDERS WILL BE CONSIDERED.

AFTER TENDER OPENING "TECHNICAL BIDS" WILL BE REVIEWED. THE BIDS WILL BE BROUGHT TECHNICALLY AT PAR BY SEEKING CLARIFICATIONS. THE BIDDERS WILL NOT BE ASKED FOR ANY PRICE CHANGE IN THEIR FINANCIAL BIDS DUE TO CERTAIN CLARIFICATIONS AND SUBSEQUENT CHANGE IN THEIR TECHNICAL PROPOSALS.
