4. Offered spare parts to be packed as per OEM standard to ensure safe transportation.
5. Bidder to quote complete description, part number, quantity, unit price & extended price.
6. Price to be quoted in **Pak Rupees (PKR)**.
7. Bidders are required to submit a bid bond of PKR 51,405.00/- (Pak Rupees fifty-one thousand four hundred and five only) in favor of Operation Manager Rig N-5 at the time of bid submission.

In case, the bidder offers required parts with superseded / replaced part number, it should be clearly mentioned in the technical / financial bid and a certificate of OEM or their authorized dealer / distributor be provided to confirm that the supplied part with new part number is 100% exact replacement to the part having part number as mentioned in the Schedule of Requirement.
