TERMS AND CONDITIONS**TOR FOR SUPPLY OF 12VOLT DC 220AH BATTERIES FOR DAKHNI GAS
PROCESSING PLANT****SUPPLIER/BIDDER GUIDELINES:**

- 1) Batteries must have warranty of 01 year and design service life of 10~12 years.
- 2) Batteries will be placed in non-air-conditioned naturally ventilated room; batteries must be able to withstand ambient temperature of 45 degree C in summers.
- 3) Bidder must be Original Equipment Manufacturer (OEM) or OEM's Authorized Partner/Distributor/Reseller/Dealer/Agent specifically for this procurement.
- 4) Bidder should strictly adhere to the specifications mentioned in the Schedule of requirement.
- 5) Bidder must have experience of at least 05 (Five) similar assignments during last 03 (three) years;
- 6) Bidder must be registered with Income and Sales Tax Department and must appear on Active Taxpayer List of FBR;
- 7) Bidder must not have been blacklisted or be in breach of performance with OGDCL or any Organization(s).
- 8) The bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
- 9) A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
- 10) A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.
- 11) Bidder/ packager/ manufacturer must accept OGDCL tender term and conditions for future spare parts procurement cases on separate packager/ manufacturer letter head.
- 12) Should the Procuring Agency deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure.
- 13) All bids must be accompanied by a Bid Bond/Security in an acceptable form amounting to PKR 100,000/-.
- 14) Price quoted shall include all applicable taxes.
- 15) Certificate that material is according to specification/requirement demanded by client.
- 16) Certificate that supplied material i.e. Batteries shall be free from any manufacturing defects along with any damage during delivery from OEM/Supplier to client shall be responsibility of supplier.
- 17) Inspection will be carried out at site. Damaged or faulty material will be replaced by the supplier at suppliers expense_
- 18) Material shall be delivered at Dakhni Gas Processing Plant, OGDCL, Jand under the sole responsibility of the bidder/supplier.

PAYMENT TERMS:

- 1) Payment shall be made from Head Office OGDCL.
- 2) Payment will be made after delivery, subject to acceptance of material by inspection committee and payment will be made after completion of store/accounts procedure.
