2. The required Bearings are to be supplied from original bearings manufacturer or their authorized dealer/ distributor. Authority letter issued by the manufacturer or their authorized dealer/distributor in favor of the bidder must be provided with the techno-commercial proposal.
3. Bids must be submitted under single envelope bidding system. The envelop must contain techno-commercial proposal.
4. Bid bond amounting to **PKR 50,000/-** is to be submitted along with the bid in favor of Operation Manager Rig N-6, OGDCL. Any bid without bid bond will be rejected out rightly.

5. Quoted prices must be firm (inclusive of GST, other taxes, and duties).
6. Bids will be evaluated on full consignment basis.
7. The bearings mentioned in this tender enquiry are required for Swivel, Model XSL-450, manufactured by M/s RG Petro Machinery Group China and is installed at OGDCL Rig N-5. Part numbers mentioned in this tender enquiry are as per OEM (RG Petro Machinery Group, China) parts manual, however, bidders can offer bearings with equivalent part number.
8. Following will be required, if bidder offered bearings with equivalent part number to be supplied from other than M/s RG Petro Machinery Group, China (OEM of the Swivel XSL-450) :
 - i. The manufacturer shall have experience of at least ten (10) years of manufacturing of offered bearings. In this regard, documentary proof is to be submitted in **English language**.
 - ii. Bidder to provide, with the technical bid, the manufacturer's company profile and sale record for last three (03) years for supply of adequate quantities of same type of bearings by mentioning client names, addresses, e-mails and phone/fax numbers. OGDCL reserves the right to re-confirm the authenticity of provided sale record from the clients.
 - iii. Bidder to provide with the technical bid, a certificate issued by the quoted manufacturer that the offered bearings are 100% compatible in design, dimensions and function/performance to the bearings mentioned in the tender enquiry and that no additional parts/alteration/modification will be required by the end user during utilization.
 - iv. Bidder to provide a certificate with technical proposal that, in case of misfit of any or all supplied bearing in the swivel (RG Petro Machinery Group China Swivel XSL-450), bidder will have to replace them immediately without any additional cost to OGDCL.
9. All bidders to confirm that offered bearings shall be supplied as newly manufactured (with the date of manufacture not later than two (02) years), not refurbished, unused and free from any defect of material and workmanship. Any defective or wrong bearing(s) shall be immediately replaced by the bidder/ supplier with new bearing(s) at no additional cost to OGDCL whatsoever.
10. Delivery period shall be **90 days** after issuance of purchase order.
11. The bearings should be boxed and packed in a compact manner to ensure safe handling and transportation during shipment.
12. The bearings are to be delivered at OGDCL Rig N-6 which, being a mobile unit, can be located anywhere in Pakistan. Bidder will be informed about exact location at time of delivery.
