1. The quotes should be sent to OGDCL Togh Gas Field, C/O Manager TCS Office Kohat, KPK in closed envelope addressed to **Field Manager/ Incharge (Process)**.
2. Quoted prices must be firm in Pak rupees on FOR basis (inclusive of GST, other taxes, and duties).
3. The variation in Quantity will not change the unit cost of material.
4. Upon receipt of material at site, testing will be done, in case of test failure, material will be returned to supplier, at the cost will be borne by of supplier.
5. Original material test certificates will be provided with material. Pumps must comply relevant standard/ASME. The same must be submitted in technical Bids at the time of submission of bids, including make, specifications, OEM details.
6. Original import documents must be provided with invoice. Used/refurbished material will be rejected.
7. The quotes will be opened on the date as mentioned in the tender notice; the supplier can mobilize his representative to site
8. Bid bond (Bank Draft/Pay Order) of Rs-**40,000/-** in favor of Field Manager Togh Gas Field at the time of bid submission by all participants.
9. The successful bidder will be bounded to provide the material as per specifications mentioned in Anex-B.
10. The successful bidder will be responsible to provide all the materials within 30 days after the issuance of P.O.
11. No advance payment will be made at the time of P.O.
12. The delivery and inspection of material will be carried out at Togh Gas Field. In case of rejection, all the transportation charges will be at Supplier's end.
13. The material delivery charges to Togh Field will be paid by the Supplier.
14. Income tax/w. holding tax deductions will be applicable as per company/govt. rules.
15. The payment will be made through cross Cheque after receiving the mentioned material at site.
16. The firm should have valid NTN and GST number and have active status on FBR website.
17. The Firm should have active Professional tax certificate of concerned Excise office, where operating business.
18. Tax submission Certificate (Annex-C) will be provided along with Invoice.
19. The offered manufacturer of pump should have 10 year of manufacturing experience.
20. Both pump and motor should be fitted on skid.
