## TOR, S:

- 1. The quote should be sent to <u>Logistic Field Kotsarang,Oil & Gas Development Company Ltd.</u>

  <u>C/O MainTCS Office Talagang, Punjab</u> in closed envelope, addressed to Operation Manager.
- 2. Only registered Suppliers can submit their bids having NTN and STRN.
- 3. The variation in Quantity will not change the unit cost of material.
- 4. The quote will be opened on the date as mentioned in the tender notice, the supplier can mobilize his representative to site in bid participation.
- 5. The Pay Order / Demand Draft of Rs. 150,000/- in favor of Oil & Gas Development Company Limited, as security deposit / performance bond& it must also be enclosed with the quotation. Deposit of successful bidder will be retained and returned / refunded after the completion of job. Rest of the bid bonds of unsuccessful bidders will be released, after award of contract.
- 6. Any bid without performance bond will not be entertained.
- 7. The successful bidder will be responsible to provide Transport for subjected material shifting on **as and when required basis**, after approval from The Competent Authority. However, 24 Hour notice for mobilization will be served by Operation Manager Logistic Field, Kot Sarang.
- 8. Convey schedule as follows:
  - a. Every Monday &Thursday (From Malang to Rig Site, Timing 1000Hrs)
  - b. Every Monday & Thursday (From Rig Site to Malang Ada, Timing 0800Hrs)
- 9. The contractor will follow convey schedule (From Malang Adda to Rig site and vice versa) provided by OGDCL security Department.
- 10. No standby charges will be given in case of non-availability of convey due to security reasons/waiting for scheduled convey at Malanag Adda.
- 11. Barite Bags/ Chemicals must be properly fastened and covered with tarpaulin.
- 12. No advance payment will be made.
- 13. The scope of work provided in the inquiry can be increase/decreased and payment will be made to the contractor as per actual work done.
- 14. The transporter will be responsible to provide HSD to the Trailers. Trailers should be in good condition. Further, pull & push & boarding/lodging will also be the responsibility of the transporter.
- 15. The Contractor shall be liable to pay all Government levies, taxes and incidentals etc. en-route.

- 16. The quotations must be inclusive of all applicable taxes like income tax/withholding tax and Provincial/ICT sales tax on services etc. Sales Tax registration certificate is to be provided with quotation as well. Annex-C from FBR will be required for Sales tax.
- 17. No mob/de-mob or stand-by charges will be given.
- 18. The payment will be made through cross cheque, after receiving the mentioned stuff at the destination.
- 19. Note: Company reserves the right to impose 40% Penalty in case of violation of TOR.
