- 3. In case the bidder is not the supplier, must submit original authority letter from supplier/principal.
- 4. Surety bond of Rs.100,000/- (Rupees One Hundred Thousand only) in the favor of Operation Manager Logistic base Kot Sarang at the time of bid submission by all participants
- 5. The quotes will be opened on the date & time as mentioned in the tender notice. The bidder can send his representative to site.
- 6. Product should be of market reputed brand new.
- 7. Successful bidder will be responsible for the provision of entire consignment as per specification of web tender at Cement/Stim Base Kot Sarang, Talagang within 30 days after award of supply order.
