#### TORS:

- 1. The quotes should be sent to Oil & Gas Development Company Limited. C/O Logistic Field TANDO ALAM, Main TCS Office, Hyderabad, Sindh\_in closed envelope addressed to Operation Manager.
- 2. Only registered Supplies can submit their bids having NTN/ STRN & FBR.
- 3. The provided vehicles should be minimum Double Axle and will not carry more than 25 to 27 M-Ton Load on each vehicle.
- 4. The variation in Quantity will not change the unit cost of material.
- 5. The quotes will be opened on the date as mentioned in the tender notice, the supplier can mobilize his representative at site to participate in bid opening process.
- 6. The Pay Order / Demand Draft of RS. 150,000/PKR in favor of Oil & Gas Development Company Limited, as security deposit / performance bond must also be enclosed with the quotations. Deposit of successful bidder will be retained and returned / refunded after the completion of job. Rest of the bid bonds of unsuccessful bidders shall be released after award of contract.
- 7. Any Bid without performance bond will not be entertained.
- 8. The successful bidder will be responsible to provide Transport for subjected material shifting on **AS AND WHEN REQUIRED BASIS**, after approval from competent authority. However, 24 Hour notice for mobilization will be served by Operation Manager Logistic Field TANDO ALAM.
- 9. Convoy schedule as follow.





- a. Every Monday, Wednesday & Saturday (From Dera Allah Yar By-Pass to UCH Wells at 1400 Hrs)
- b. Every Monday, Wednesday & Saturday (From UCH Wells to Dera Allah Yar By-Pass at 1000 Hrs)
- 10. The contractor will must follow convoy schedule provided by security department.
- 11. No stand by charges will be given in case of non-availability of convoy due to security reasons/waiting for scheduled convoy at Dera Allah Yar By-Pass.
- 12. Barite/Chemical Bags must be properly fastened and covered with tarpaulin.
- 13. No advance payment will be made.
- 14. The scope of work provided in the inquiry can be increased/decreased and payment will be made to the contractor as per actual work done.
- 15. The transporter will be responsible to provide HSD to the Trailers. Trailers should be in good condition. Further, the pull & push & boarding/lodging will also be the responsibility of the transporter.
- 16. The Contractor shall be liable to pay all Government levies, taxes and incidentals etc. en-route.
- 17. The quotations must be inclusive of all applicable taxes like income tax/withholding tax and Provincial/ICT sales tax on services etc. Sales Tax registration certificate is to be provided with quotation as well. Annex-C from FBR will be required for Sales tax.
- 18. No mob/de-mob or stand-by charges will be given.
- 19. The payment will be made through cross Cheque after receiving the mentioned stuff at site.
- 20. Note: Company reserves the right to impose 40% Penalty in case of violation of TOR.
