  - b- The envelope marked as **“FINANCIAL PROPOSAL”** will be in the custody of field management without being opened;
  - c- Technical proposals will be evaluated as per TOR/SOR without reference to the price and proposals which does not conform to the standards and criteria in TOR/SOR will be rejected, during the technical evaluation no amendments in the technical proposal shall be permitted. Financial proposals of only technically qualified suppliers will be opened and unopened financial proposals of technically non-qualified bidders will be returned.
