



- Warranty is required for the offered parts against defect in performance, material and workmanship and such warranty must be provided with the technical proposal.

4. Offered Parts must be manufactured by CATERPILLAR (Bidder to provide documentary evidence in this regard) and to be packed as per OEM standard to ensure safe transportation.
5. Bidders to quote all Parts with complete description, part number, quantity, unit price & extended price.
