- 1. The vendor will provide minimum 01-year replacement warranty, with provision of sign/stamp warranty card.
- 2. Vendor will also provide acid water (proper gravity) required for Batteries.
- 3. The batteries provided should be fresh manufacturing date. (not more than 03 Months old at the time of supply)
- 4. Only registered firms/ vendors from Taxtation Authorities (having valid registration of GST/NTN) with active status , (attach copy) can submit their bids.
- 5. The proposal indicating the quoted price in figures as well as in words along with essential literature / brochures if any, would be enclosed in an envelope.
- 6. All the prevailing Government Taxes will be applicable.
- 7. The supply must be delivered within 01 Month from the date of issuance of Purchase Order.
- 8. Surety bond (ORIGINAL) of Rs.100,000/- (One Hundred Thousand Rupees) in favor of Operation Manager Logistic Field Kot Sarang at time of bid submission by all participants.
- 9. In case the qualified tenderer withdraws, fails or short supplied of required items, substandard material, then the surety bond shall be liable for forfeited.
- 10. If the material/ goods supplied or any portion thereof is declared defective by the inspection committee at the time of ultimate use/inspection, it shall stand rejected, the tenderer shall replace with new one or according to the warranty with 07 days at their own risk and cost.
- 11. The purchase reserves the right to increase or decrease the quantities required.
- 12. The successful bidder will be responsible to provide the samples of ordered items if required by the committee before actual delivery. The acceptance of the items will be subject to the inspection by the OGDCL constituted inspection committee.
