Sealed bids are invited under Competitive Bidding Procedure on Single Stage single Envelope Bidding Procedure. Bid should be valid for 45 days.

01. Bidders are required to download the master set of tender documents from [www.ogdcl.com](http://www.ogdcl.com) under the title "Tender". Bidder shall follow the instruction mentioned in the master tender documents.
02. 100% payment will be made through cross cheque only payable to suppliers company after completion of assignment and submission of invoices, annex "C" with required documents and completion of store and accounts procedures.
03. All admissible taxes will be deducted as per rules.
04. Delivery of material shall be at Dakhni Gas Processing Plant, Tehsil Jand, Distt: Attock, free of any damage.
05. Unloading of material will be provided by OGDCL at site under suppliers supervision. OGDCL will not be responsible for any damage occurred during unloading / loading of material.

06. Supplier shall provide test and warranty certificates.
07. In case of damaged material/malfunction during operation supplier will change the breaker free of cost at supplier's expense.
08. The supplier will have minimum of 05 years of past experience in the supply of same item.
09. Installation of Air circuit Breaker at Dakhni plant will be in supplier's scope.
10. Bidders quoting Equivalent ACB must provide a certificate from at least three E&P companies of foreign jurisdiction other than bidders/manufacturers own country, stating that equivalent (ACB) are used by them and performance of such ACB is found satisfactory. Copies of Purchase Orders (unpriced) must also be provided. The certificate(s) / sale record is mandatory and due to non-submission thereof, the bid will be rejected.
11. Delivery time shall be 60 days from the issuance of LPO.
