- 3. Quoted prices must be firm in Pak rupees on for Bettani Oil & Gas Field basis (inclusive of GST, other taxes and duties)
- 4. The variation in Quantity will not change the unit cost of material.
- 5. The quotes will be open on the date as mentioned in the tender notice; the supplier can mobilize his representative to site to participate in the bid opening meeting.
- 6. Bid bond of **Rs 50, 000/-** in favor of Field Manager Bettani Oil & Gas Field is mandatory along the bid submission.
- 7. Successful bidder will be responsible/bounded to provide the above mentioned equipment/material as per specification mentioned in the SOR.
- 8. The successful bidder will be responsible to provide all the materials within 30 days after the issuing of P.O date.
- 9. No advance payment will be made at the time of PO.
- 10. The material delivery charges to Bettani Field will be paid by supplier/bidder.
