3. Material must be brand new packed in sealed drums.
4. Brand should be of American/European.
5. Suppliers must provide an operation manual and warranty for material.
6. Suppliers should bring sample desiccant at the time of the bid opening.
7. The supplier should furnish 03 years' experience certificate for supply of the same item to other Petro chemical or oil and gas industry.
8. Suppliers should be ISO Certified.
9. Single stage, single envelop bidding will take place along with Item wise evaluation criterion for the bids.
10. Custom clearance in supplier's scope.
11. The material will be delivered to Dakhni Plant, the delivery charges to Dakhni gas processing plant to be borne by the supplier / bidder.
12. The tender committee reserves the right to increase or decrease the quantities or may cancel any or all items shown in the SOR without assigning any reason thereof.
13. Payment will be made through cross cheque and will be released when once successful inspection of material at site is completed. OGDCL has the right to reject whole or part of supplied plates if inspection results found unsatisfactory.
14. Any damaged material during onsite inspection will have to be replaced by the supplier without any extra charges within 04 weeks.
